

Junior Explorer Day Camp

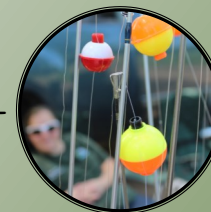

What is the Junior Explorer program?
